

FACTS**WHAT DOES Imagination Realty Network DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Name, Date of Birth, Social Security Number, Contact Information, and Addresses
- Credit, Income, Account Balances, Real Estate Owned, and Collateral Data
- Credit History, Qualification Details, Rate and Terms Offered

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Imagination Realty Network chooses to share; and whether you can limit this sharing.

How does Imagination Realty Network protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. See www.GolRN.com/privacy for more details.

How does Imagination Realty Network collect my personal information?

We collect your personal information, for example, when you

- Contact us by phone, email, text message, online inquiry, or submit a mortgage application
- Schedule a consultation, provide financial, employment, or property information
- Authorize us to obtain a credit report

We also collect your personal information from other companies. OR We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. Some sharing cannot be limited because it is essential for us to offer our services to you.

What happens when I limit sharing for an account I hold jointly with someone else?

We will discontinue sharing your information but will continue to share any joint account holder(s) information. The joint account holder(s) may also request that we discontinue any information sharing by calling (737)321-5333, ext. 4, or otherwise by submitting a written request via mail or e-mail.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies:

- Imagination Realty Network, LLC

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies:

- Examples include lenders, title companies, insurance providers, appraisal companies, credit reporting agencies, verification service providers, etc. involved in the real estate transaction.

Joint marketing

A formal agreement between non-affiliated financial companies that together market financial products or services to you:
